**Subject : - Recognition of Service Association under the CCS(RSA)Rules, 1993.**

Sir,

With reference to your letter No WF(JCM)/01/ (Misc) dated 18/07/2017 on the above cited subject this is to inform you that the recognition of Service Associations/ Unions of IMD was granted for a period of five years w.e.f. 14.02.2003 under CCS(RSA)Rules, 1993 (i.e. up to 14.02.2008). The case of renewal of recognition of these Unions/ Associations is still under consideration with MoES.

2. As per Rule 5(d)(i) of DoP&T Notification No.-2/10/80-JCA dated 05.11.1993, "The Association re-presents minimum 35 per cent of total number of a category of employees provided that where there is only one Association which commands more than 35 per cent membership, another Association with second highest membership, although less than 35 per cent may be recognized if it commands at least 15 per cent membership".

3. The total Sanctioned strength of Non-Gazetted staff as on 01.07.2016 in IMD excluding Industrial staff is **4292**. The actual strength as on 01.07.2016 is **2575**. The total membership of IMD NGSU as on 01.07.2016 is 1266. The

membership works out to be ~~49.17~~ percent against 35 percent required under Para No. 5d(i) of DoPT notification No. 2/10/80-JCA(Vol. IV) dated 5.11.1993.

4. Since IMD NGSU has completed all the formalities at the time of initial recognition it therefore this union is requesting for the renewal of recognition under rule 5 of the CCS(RSA) Rules, 1993 instead of fresh recognition. The following documents in this regard are enclosed herewith for your ready reference.

- (iii) Name of the Office-bearers
- (iv) List of Members whose subscription is deducted towards the membership of IMD NGSU through check-off-system

IMD NGSU satisfies all the terms and conditions stipulated under CCS(RSA)Rules, 1993 and DoPT OM No.2/13/98-JCA dated 24.05.2001. It is therefore requested that the approval of Minister-in-charge as required under Para No.1(viii) of Annexure II to DoPT OM NO. 2/10/80-JCA dated 31.01.1994 may be accorded for renewal of recognition of IMD NGSU.
