With reference to the draft Recruitment rules of Scientific Assistant uploaded in the website vide file number No. A-11045/Restructuring/SA/3014/E(III) dated 30.01.2019, the comments of IMD NGSU are given below for necessary inclusion in the draft.

"Scientific and Operational" term is mentioned in Column-3 under the head Classification in the draft RRules will not be accepted by the DoPT as the term is not defined in the definition of Classification. It is therefore requested that it should either be included in the column-1 under the head name of the post- Scientific Assistant (Scientific and Operational) or it should be included in the preface of the notification part instead of Schedule. In this connection copies of RRules of Department of Biotechnology notified vide GSR-355(E) dated 11.05.2012 and GSR-728(E) dated 24.09.2012 are enclosed herewith for your ready reference.
- 2. Kindly include Scientific Officer Grade-2 and Scientific Officer Grade-3 in the list of members of Group-B Departmental Promotion committee (for considering promotion) and Departmental Confirmation Committee (for considering confirmation) mentioned under Column-12 along with Scientist-D and Scientist-E as they have the same Pay level and SO-2 & SO-3 are also the promotional cadre of Scientific Assistant.

## (Department of Biotechnology) NOTIFICATION

New Delhi, the 11th May, 2012

GS.R. 355(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Department of Biotechnology, Group 'A', Gazetted Posts (Non-Ministerial and Scientific) Recruitment Rules, 2001, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the Group 'A' scientific posts in the Department of Biotechnology, namely:

- Short title and commencement (1) These rules may be called the Department of Biotechnology (Group 'A', Scientific Posts) Recruitment Rules, 2012.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Definitions In these rules, unless the context otherwise requires,
- (a) "age" means the upper age limit as specified in the Second Schedule;
- (b) "candidate" means the person who is eligible for consideration for any post specified in the First Schedule;
- (c) "Department" means the Department of Biotechnology;
- (d) "competent authority" means the authority specified by the Central Government as such, from time to time;
- (e) "controlling authority" means the Secretary in the Department of Biotechnology,
- (f) "post" means a post of Scientist as designated under column (1) of the First Schedule;
- (g) "Schedule" means a Schedule appended to these rules.
- 3. Number of posts, classification and scales of pay- The number of posts, their classification and the scales of pay attached thereto shall be as specified in the First Schedule.

6. Saving. - Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, exservicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
