Subject: - Discrepancy in the nomenclature of canteen staff - regarding

I would like to draw your kind attention to the DoPT OM No. 03/02/2009-Dir(Can) dated 05.06.2014 (copy enclosed) wherein the existing hierarchy of posts and duties/responsibilities of various canteen employees working in Non-statutory Departmental Canteens functioning in the Central Government offices have been given.

It is further clarified in the OM that the post of Tea/ Coffee Maker, Bearer and Wash Boy had been clubbed together and re-designated as Canteen Attendant on the recommendations of Sixth Central Pay Commission, it has been observed from the data available on metnet that the above order has not been implemented by the department and office is still using the old nomenclatures of these posts.

NGSU has raised this issue in the year 2017 vide letter No. IMD NGSU/2017/17 dated 30.01.2017 but no action was taken up by then DGM. It is requested that an order regarding re-designation of the post of Tea/ Coffee Maker, Bearer and Wash Boy as Canteen Attendant may be issued and uploaded on metnet. In addition to this, the name of the post of Coupon Clerk may also be changed to Clerk on metnet as the office order in this regard has already been issued vide DGM's office order No. A-11038/1/88-E.I. Dated 20.07.2009 (copy enclosed).
