

DoP&T has clearly mentioned that Group B ministerial posts may be given gazetted status only on very special considerations, such as, the following:-

- 1) The officer already had gazetted status before appointment.
- 2) The officer has commissioned or gazetted officers under his orders.



- 3) The officer performs duties of a technical character requiring special qualifications.
- 4) The office is periodically left in charge of the office during the absence of his superior on tour and has to dispose of business and to deal with gazetted officers of businessmen/ on behalf of his superior.
- 5) Regarding Gazetted status, it is to mentioned that IMD had initiated a proposal to upgrade few hundred posts of Scientific Assistant to the post of Astt.Met.Gr.II few years back so that all the offices where officer-in-charges are Scientific Assistant can be managed by a gazetted officer, which was turned down by the ministry. The same can be achieved by giving the Gazetted status to Scientific Assistant.
- This union still holds their demand of inclusion of "operational" term in RRules of SA. Our determination has become stronger in the current situation when IMD employees are giving their services in the epidemic COVID. We comes under essential services and therefore it should be reflected in our recruitment rurles. The "operational" term may be included in the notification part of the RRules only.

It is requested that the above, inputs kindly may be incorporated in the Recruitment rules of Scientific Assistant.
