## RESOLUTION FOR APPROACHING APPROPRIATE FORUM

**Subject:** The members of Union Council pointed out at the lower rate paid as compensation for the night duties performed by the Group B and C employees of this department & urged General Secretary to clarify the matter. General Secretary explained that we had been pursuing the matter with HQ in a continuous manner to get the formula of night duty allowances to be applied to the present scale and implementation of Hon'ble CAT Jodhpur verdict. But the department and the ministry are not serious in this issue.

The discussion was held in session "Whether the night duty of the employee is to be considered and paid appropriately to fulfill the departmental mandate of operational nature of duties". The Union council demanded for legal action in the matter as it is linked to employees' welfare & benefits as there is no action by IMD.

The subject matter was placed before the Union Council session held on 21<sup>st</sup> and 22<sup>nd</sup> Sept 2016. The same was again discussed by the Central Executive Committee on 21.04.2017 and this committee has unanimously decided to approach the appropriate forum to address the subject issue. The CEC, NGSU, New Delhi has decided to approach CAT Bangalore through the Regional Executive Committee of Chennai and nominated Com. B.L. Shivaprakash, Deputy Regional Secretary, RMC Chennai and two members from the Bangalore unit as NGSU representatives to take necessary actions in the matter on behalf of CEC, NGSU New Delhi. General Secretary requested Council members to express their views in the matter. As all agreed, the following resolution was placed before session.

*Resolution No. 1 :- The Central Executive Committee meeting held on date 21<sup>st</sup> April 2017 of NGSU has passed a resolution that NGSU shall approach Honorable CAT Bangalore through Regional Executive Committee, Chennai to clarify the "night duty compensation formula to be applied on the present scale" of employees in IMD.*

*Further it is nominated Com. B.L. Shivaprakash, Deputy Regional Secretary, RMC Chennai, Com. Hanumantha Raju, and Com. M. Venkatesh from MC Bangalore branch as nominated representatives from NGSU to take necessary actions in this matter on behalf of CEC, NGSU, New Delhi.*
