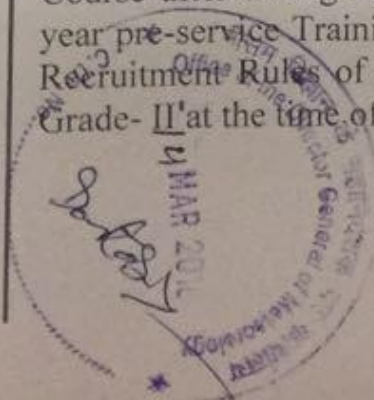
Sub: Request for amendment in the Recruitment Rules of  
Scientific Assistant / Meteorologist-A/ Meteorologist-B- regarding

Sir,

We take this opportunity to convey our heartfelt gratitude for your benevolent and sympathetic support to our cause. This union would like to thank respected Secretary and his esteemed team who has done all the efforts to notify the long pending Recruitment Rules of Scientific Officers of IMD.

I would like to draw your kind attention to the meeting held with your goodself on 08.02.2018 at Avni Hall, Prithvi Bhawan wherein stake holder has raise the issue of induction of "Scientific and Operational" in Recruitment rules. It was suggested by Joint Secretary, MoES in the meeting that Scientific and Operation term may be introduced in the Recruitment Rules of Scientific Assistant / Meteorologist-A/ Meteorologist-B.

It is further mentioned that at present 4 months Integrated Met. Training Course and 6 months Forecaster Training Course is necessary for Scientific Assistant for promotion to the post of Meteorologist-A and Scientific Officer Grade-I respectively. It becomes very difficult to undergo a six months Forecaster Training Course after the age of 50 years. It is therefore suggested that one year pre-service Training in Meteorology may be incorporated in the Recruitment Rules of Scientific Assistant as given to Meteorologist Grade- II at the time of joining the department.

In view of above, it is requested that the following amendments may be incorporated in the Recruitment Rules of Scientific Assistant /Meteorologist-A/ Meteorologist-B.

1. Removal of Diploma from Educational Qualification.
2. Induction of "Scientific and Operational" term in RRules.
3. One year Pre-service Training in Meteorology may be incorporated
