In continuation to our letter dated 11.03.2016, we are very glad to understand that UPSC has permitted to release of promotion list from Group B to Group A, however UPSC has given this approval under the condition that the promotion list can be released with SIX years of regular service as AM-I.

In view of the above condition I would like to draw your kind attention that in IMD SIX years of continuous service is practically not possible due to acute stagnation. Moreover the AM-II post carries a grade pay of Rs.4600/- which is a Gazetted post in IMD. We had earlier represented that TWO years of regular service may kindly be considered in AM-I post. The same clause is already mentioned in the column 11 of draft RR's for SO-I post.
