Since then this union had been approaching the IMD administration on a continuous manner to implement the restructuring benefits but **Unfortunately IMD Administration took SEVEN months to release the creation order along with post distribution on 01.07.2015.**

As per govt. orders approval of UPSC is required to fill the newly created posts and to get the necessary relaxation for filling up the new posts. **IMD administration has not approached UPSC so far.** As per the DOPT orders once the creation order is released the Recruitment rules should reach DOPT under consultation with UPSC within **One to Three months** period. The three months period is already over and the case is still pending with IMD/MoES. It's beyond doubt that IMD has not been following the instruction and guidelines framed by the competent agencies.

After the Group "B" cadre restructuring was approved on 11.12.2014 many staff members who have been retiring are actually eligible for Gr. A promotion by the criteria of service, training etc but even then they retired with a heavy heart as they have not been benefited by the cadre restructuring because of unnecessary delay in process by the IMD administration.

This union would like to draw your kind attention that due to the delay methods used by IMD deliberately on one hand diminishes the your special efforts and on the other hand the possibility of surrendering of vacant posts is at high risk.

In view of the above this union humbly requests you to **kindly intervene for getting our promotion list released and filling up all the promotional vacancies** and also give us an appointment to explain our practical and official issues to you in person .
