Sir,

The following four issues are very important raised by our union and need your personal attention. It is presume that neither IMD nor MoES is serious about these issues. Either they are reluctant to do anything for the Group-B and Group-C staff of IMD or they are not able to understand the sensitivity of the cases.

- 1. Scientific and Operational status to IMD.
- 2. Implementation of Mali Committee Report.
- 3. To prepare a Document named "Hour of Employment for IMD employees" which will elaborate all the rules related to rosters, number of Hours of work, period of rest, length of continuous duty, compensation package for extra duties etc. The most important thing is we want this document to be notified in the Gazette of India.
- 4. To prepare the Manual of India Meteorological Department. In this regard DO Letter No. K-11022/43/2015-ARC(pt) dated 08.09.2016 may kindly be referred to.

It has been noticed in last many years that most of the time is wasted between IMD and MoES while processing the case. Since all the above cases are policy matters and as per guidelines of DoPT policy matters should be taken up by the Ministry itself, it is therefore requested that MoES may take up these cases at their end without sending the file to IMD. However advice/ comments may be obtained from IMD whenever it feels necessary.
