Sub: Regarding implementation of the decisions taken in the meetings. Ref.: Our letter No. IMD/JCM/07 dated 16.08.2016 (Copy enclosed).

Sir.

This has reference to our meeting dated 01-09-2016 wherein it was revealed that our letter dated 16-08-2016 was missing. However, the copy of the same is enclosed for your perusal. It was also brought to our notice that the names of representative for deciding the Transfer Order of 109 S.As has not been provided by the Association/Union.

We have already submitted the names of G.S IMD NGSU/NGSSA vide our letter No.IMD/JCM/09/2016 dated 26th August, 2016. As advised by your goodself, both GS IMD NGSU/NGSSA will participate alternatively after the finalisation of transfer policy.

Several decisions were taken by your good self, but the same could not be implemented till date due to some biased person manning the Administration. It seems that some officials of the department do not want to run the administration on the basis of sorting out various issues by Employees and management amicably and not allowing the new DGM & DDGM (A&S) to act in transparent way.

Following few main issues are being highlighted for immediate action:-

- As discussed and agreed in weekly meeting with all Unions/ Association on 01.09.2016, transfer policy may be finalised first and upload on METNET before initiating any transfers.
- A circular may kindly be issued and circulated so that those who have been transferred out of Delhi and are presently posted at out stations to get an equal opportunity to place their request.
- 3. The person who have already completed their period of stay at HQ or at out stations (i.e.2 years) may be posted back to their parent office/requested stations at the earliest.
- 4. The transfer of those employees who have been on long leave just after submitting the joining at the transferred place should be considered only on medical conditions (as mentioned in transfer policy) and not otherwise.
- Out of turn transfers/postings should be avoided to stop the discrimination and if could not be avoided due to any reasons, same may be mentioned in the file noting. Due weightage should be given to employees who have seen more number of transfers/ period of stay at the station.

- 6. As decided before the Secretary, MoES Rotational Policy as per CVC/ DoP&T Guidelines should be implemented immediately.
- 7. Despite direction of DGM, membership subscription fee is still not deducted. The same may be deducted from the salary of September, 2016.
- 8. As assured by the DGM on 01.09.2016, executive order for revival of Housing Advisory Committee & Constitution of Infrastructure Advisory Committee should be issued immediately.
- 9. Facility of filtered drinking water facility at IMD Campus in DGM, Sat Met, RMC/DDGM (UI) building & Guest house should be provided at the earliest.
- 10.The matters of 50% upgradation of Mechanic (Industrial) & recruitment of MTS are still pending.

In view of the above, we are expecting that your good self will look into the matter personally and issue executive orders to implement the above mentioned decisions immediately, so that the atmosphere of faith and harmonious relations could be maintained for better efficiency.
