Sub: Gross Human Rights violation in IMD.

Respected Sir,

We are greatly pained to inform you that the lackadaisical attitude of IMD administration is going on unabated since several years and the Ministry of Earth Sciences seems to be completely indifferent to the plight of the Group B officers (both Gazatted & Non-Gazatted) of the Department.

It also seems that IMD administration and the Ministry have not learnt any lesson from the untimely death of Late Radhika Rani who succumbed to the atrocious agony caused to her by the IMD administration.

We are writing to you, once again, because another victim has succumbed to the insensitive, inhuman behavior of this Department. Shri Naresh Kumar, Meteorologist-A is still hanging between life and death due to relentless mental torture given to all the Non-Group-A officers and staff members of IMD.

You are already aware that there is no career prospect for any of the Non-Group-A employees in IMD which is already a matter of huge frustration among all of us. Adding to the woes, we are exposed to frequent transfers at the whims of the administration, forced to work round the clock without any compensation causing irreparable damage to the mind and body of all the Group "B" employees. As such it is only a matter of time when many of us fall prey to such vicious and mala fide actions of the Department.

The hypocrisy was evident when the IMD administration didn't even spare people performing operational duties from attending election duties. Many were forced to attend the election trainings despite performing their strenuous and continuous night duties.

We condemn the utter selfish acts of IMD administration and demand immediate suspension of the officers instrumental in forcing Shri Naresh Kumar to take such an extreme step.

To stop repetition of such unfortunate tragedy in future, we demand:

1. Immediate suspension of I/C AMO Palam.
2. Appropriate action against Head RMC, New Delhi & I/C AMSS Palam.
3. A policy, rotating all Heads of RMC's and other major stations after every three years.
4. Compulsory posting of Group "A" officers as "Head" and also as "Batch I/C" at all airports to stop exploitation of Group "B" employees at the stations.
5. Immediate release of the promotion lists in all Group "B" and Group "C" cadres to reduce frustration among the employees.

In the event of the non-compliance of this letter we'll be forced resort to non-stop agitation till justice is done.
